### Cautions and Warnings

**⚠ WARNING** This device is configured for 12 V DC operation. Do not connect to a higher voltage. Use only with NRTL-approved Class 2 power supplies.

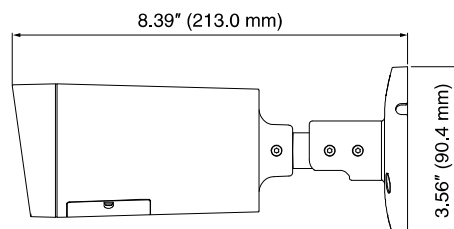
**⚠ WARNING** IR emitted from this product. Do not view directly with optical instruments. Do not stare directly into the lamp at a distance of less than 3.3 ft (1 m).

**CAUTION** Class 1 LED product. Invisible LED radiation (850 nm). Avoid exposure to beam.

### Important Safeguards

- Read and keep these instructions.
- Do not aim the camera toward a bright light source for extended periods to prevent damage to the imager. Avoid operating the unit under or close to unstable light sources or close to fluorescent lamps or objects reflecting light.
- Do not touch the camera lens.
- Do not drop the camera or subject it to physical shock.
- Do not use a strong or abrasive detergent when cleaning the camera.
- Avoid operating or storing the unit in extremely humid, dusty, or environments where the operating temperature is outside the recommended range of -22°F to 140°F (-30°C to 60°C).

### Before You Begin

Before you begin, check that you have received all of the parts listed below. If any parts are missing or damaged, contact your dealer immediately.

- Camera
- Quick Installation Guide
- Mounting template sticker
- Allen key (L-wrench)
- Self-tapping screws (3)
- Plastic anchors (3)
- Power pigtail

Tools needed (not supplied):

- Cordless drill
- Phillips screwdriver

### 1 Preparing the Mounting Surface

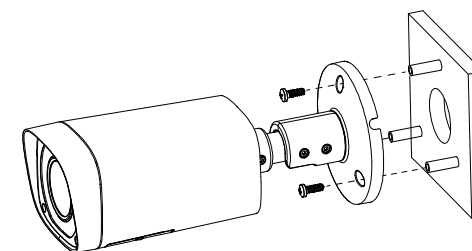
1. Inspect the site where you want to install the camera. The mounting surface must be flat and capable of supporting at least three times the weight of the camera and bracket.
2. Remove the backing from the mounting template sticker and affix the sticker to the mounting surface.

**Note** If you are using the side exit for the cable, note the orientation of the cable exit notch. In outdoor installations the notch should point downwards to prevent water from entering the camera housing.

3. Drill three screw holes at the locations indicated on the mounting template sticker and insert the three supplied plastic anchors in the holes.
4. If you are flush mounting the camera and want to store the cables inside the wall or ceiling, drill a hole in the center of the mounting template and then pull the power and video cables through the hole.

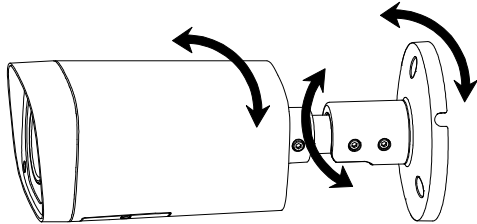
### 2 Mounting the Camera

1. Connect the power and video cables.
  - a. Connect the power connector of the camera to a 12 V DC power source.
  - b. Connect the BNC connector of the camera to a coaxial video cable.
2. Attach the camera to the mounting surface using the supplied screws (or other suitable mounting hardware).



### 3 Aiming the Camera

1. Using the supplied Allen key, loosen the adjustment screws on the bracket arm.
2. Set the camera to the desired position.



3. Tighten the adjustment screws.

### 4 Adjusting the Zoom and Focus Settings

1. Using a Phillips screwdriver (not supplied), remove the control panel cover on the underside of the camera to access the zoom and focus controls.
2. Set the lens zoom and focus.
  - a. Loosen the locking screw on the zoom ring, move the zoom ring counterclockwise to zoom in (T), or clockwise to zoom out (W), and then tighten the locking screw.
  - b. Loosen the locking screw on the focus ring, move the focus ring counterclockwise to focus on a distant subject (F), or clockwise to focus on a nearby subject (N), and then tighten the locking screw.
3. Replace the control panel cover.
